Glickert previously was a member of the Historical Society of University City's board.

For many years after her council tenure ended, she regularly attended council meetings and sometimes got involved in issues herself, such as with the trolley.

"She had some very strong convictions and interests," recalled state Rep. Joe Adams, a former University City mayor. "She was very passionate about the city."

Among her causes: **opposing** the erection of a statue of rock 'n' roll pioneer Chuck Berry on city-owned property in the Delmar Loop area; it was dedicated in 2011.

She didn't like taxpayer money paying for lighting and maintenance for the privately financed statue and raised questions about Berry's criminal record.

Glickert, a graduate of Ursuline Academy, worked for many years as an administrative secretary for Washington University's sociology department.

Among other survivors are two other sons, Paul Glickert of Port Charlotte, Florida, and Stephan Glickert of University City; 10 grandchildren and four great-grandchildren.

She also was involved with efforts to honor local history. She helped begin a nonprofit organization that worked to preserve the Sutter-Meyer House, which dates to the 1870s and where her grandparents once lived. Until her death, she was a board member.

Burial will be at 10:30 a.m. Monday at Calvary Cemetery in St. Louis. A memorial Mass will be celebrated at 10:30 a.m. March 5 at All Saints Catholic Church, 6403 Clemens Avenue in University City, followed by a reception.

UNIVERSITY CITY — Elsie Beck Glickert, who followed up a stint as a University City councilwoman with many years of activity on various civic issues, died last week (Jan. 28, 2022) at her home. She was 96.

In the past decade, she was in the news for opposing the Loop Trolley, acting as one of the plaintiffs in two unsuccessful lawsuits against the project. In 2012, she called the trolley "the Streetcar Named No Desire to Nowhere."

Glickert was a city council member from 1969 to 1980, deciding against running for another term that year. Over the years, she also was a founder of the Sadler-Bellemoor Neighborhood Association and a member of the city's human relations and parks commissions.

A son, Michael Glickert, who also is a former University City council member, said she regarded her opposition to housing discrimination and redlining as among her most significant work.

## Elsie Beck Glickert, former U. City councilwoman and civic activist, dies at 96
