

Annex and Trinity Construction Progress Update

The renovation of the historic Annex and Trinity buildings behind City Hall continues, with significant progress in mechanical and plumbing systems happening over the next few months. The approximately 36,000-sq.-ft. Annex is being transformed into a cutting-edge police headquarters, while the 8,512-sq.-ft. Trinity building will serve as a multipurpose municipal court facility with areas for public use.

Currently, construction has shifted from demolition to the initial stages of new work, with a focus on mechanical, plumbing, and electrical rough-in tasks, as well as site utility installations. This phase of mechanical and plumbing progress includes:

- Installing critical infrastructure for HVAC systems
- Routing plumbing systems to align with the modernized building layouts
- Coordinating with electrical installations to ensure seamless system integration
- Building out a new IT room for City and police communications, 911, surveillance systems, etc.

These activities will remain the core focus for the coming months as the buildings advance toward their targeted completion in 2026.

Throughout the renovation, the historic facades are being carefully preserved, while the interiors are updated to meet modern operational standards. Public services amenities, including a new accessible entrance, enhanced parking, and full ADA compliance, are integral to the project. These updates will ensure both buildings provide state-of-the-art facilities tailored to their respective functions while honoring their historical significance.

MARKET AT OLIVE



Market at Olive Progress: What's Happening this Spring

Spring is shaping up to be an exciting season for the Market at Olive with key milestones unfolding. Following is a quick look at what's been accomplished and what's on the horizon.

TARGET: Construction for the Target store and its parking garage continues to make steady progress. Foundations for the garage are complete and structural concrete pours for the parking deck are well underway. The final pour -- number six of six -- is expected in March. This will be followed by finish work, such as light poles and decorative mesh taking shape in April. Store foundations also are scheduled to begin in mid-April, marking a significant next step for the project.

DIERBERGS: The development team for the Market at Olive also announced late last fall that Dierbergs plans an exciting addition to the community's retail offerings.

Thanks to the development team of Bob Clark (Clayco), Larry Chapman (Seneca Commercial Real Estate), Caroline Saunders (general counsel), and David Hutkin (Hutkin Properties Group, LLC), the Market at Olive has already transformed into a vibrant shopping destination. Stay tuned for more updates as the project continues.

Dear Neighbors,

It has been my honor and privilege to serve as a Council member for University City representing Ward 1 for the past six and a half years. I recently made the difficult decision to resign from this position effective January 1 to step into what I hope will be an even more impactful role representing University City as your Missouri State Representative for District 86. I was sworn in on January 8, 2025.

During my time on the Council, University City faced significant challenges, including the COVID-19 pandemic in 2020 and the destructive floods of 2022. These events tested our community's resilience and strained our resources. However, through collaboration and determination we made progress that reflects the hope and promise of our community.

Highlights of our achievements include:

- Advancing the Detention Basin Project, initiated in 2018
- Attracting over \$500 million in economic development investment since 2018
- Opening the Market at Olive, anchored by Costco, with construction in progress for a new Dierbergs and the largest Target store in the St. Louis region
- Welcoming Crescent Plumbing's new headquarters on Olive, returning valuable property to the tax rolls
- Expanding housing options with developments like McKenzie and Avenir Apartments on Delmar, and Subtext LOCAL apartments in the Loop
- Anticipating the opening of the Tru by Hilton hotel on Kingsland
- Enhancing public safety with restored ambulance services, three new ambulances, a new pumper truck, and a 100-foot ladder truck on order
- Beginning restoration of the historic Annex and Trinity buildings to create a state-of-the art police headquarters and dedicated space for our municipal court, with completion set for early 2026
- Demanding greater accountability from MSD, resulting in long-overdue tunnel cleanouts

As I begin a new chapter in Jefferson City, I remain committed to advocating for University City. My priorities specific to our district include addressing flooding, securing funding for stormwater mitigation projects, and championing public safety. Together, we can continue building a brighter future for our community.

March Dates for Spring Leaf Collection

Leaves and other yard waste must be placed in brown, biodegradable yard waste bags with a City yard waste sticker affixed to each bag. Stickers are required from January 1 through October 14. Bags should be placed at the front curb on your regular trash collection day.

All leaves must be raked and placed curbside by Sunday evening prior to the start of the scheduled collection week. Only leaves will be collected. Do not include gumballs, branches, or other yard debris.

Tree Cleanup After Storms



As spring and summer bring warmth and renewal, we'd like to remind you of the City's approach to handling storm-related tree damage. The Public Works Department has established the following priorities for storm cleanup:

1. Clearing major arterial roads to ensure emergency vehicles can pass
2. Clearing minor or secondary roads that are not main thoroughfares
3. Clearing driveways blocked by fallen limbs or trees. If trees or limbs from private property fall onto City streets or sidewalks, they will be moved to the property line
4. Collecting storm debris from affected areas
5. Removing fallen limbs from City trees in public parks

It's important to note that the City does not remove limbs or trees that have fallen from private property, except as outlined in priority #3.

While storm cleanup can make trees feel like a burden, they play a vital role in combating climate change. Trees remove carbon from the atmosphere, mitigate stormwater and help reduce the impact of storms – making them unsung heroes in sustaining our planet's health.

Recycle Electronics at University City's Free Drop-Off Event

Are old TVs, computers, routers, cell phones, cords, or battery-operated devices cluttering your home? University City is hosting a free electronics recycling drop-off event on Sat., May 10, 9 a.m. to 12 p.m., at Heman Park Community Center parking lot, 975 Pennsylvania Ave.

DETAILS:

- Spring event limited to electronics recycling; document shredding will be offered this fall
- Open to St. Louis County residents only; not available for businesses
- Recycle up to two TVs or monitors per vehicle for free while funding lasts
- Additional items will be charged \$30 for tube TVs/monitors, \$10 for flat screen TVs/monitors
- Most other electronics can be recycled for free with no item limit

2025 Annual Business License Requirements and Renewals

A business license from University City is required for any persons engaged in any business, occupation, pursuit, profession or trade, or in keeping or maintaining any institution, establishment, articles, utility or commodity as specified in the Municipal Code Section 605, Business Regulations.

Business licenses are issued by the University City Finance Department to businesses authorized by City officials to operate within the City of University City. Business license fees apply and must be paid to receive a business license. All occupational, business, and other licenses are valid from May 1 of the current year to Apr. 30 of the following year and must be renewed annually. All such licenses are due and payable on or before Apr. 30 each year.

University City Powers Up: EV Charging Stations Coming Soon!

University City is thrilled to announce an exciting sustainability initiative aimed at supporting the shift to greener transportation. Through federal funding from the Energy Department and the Federal Highway Administration (FHWA), the City plans to install 32 electric vehicle (EV) charging stations along Delmar Blvd. in the vibrant Delmar Loop area.

This project underscores the City's commitment to environmental stewardship by addressing the shortage of public EV charging stations in the region. By promoting the adoption of electric vehicles, the City seeks to reduce greenhouse gas emissions and combat climate change while making sustainable transportation more accessible to residents and visitors.

The grant process, led by the Director of Economic Development, demonstrates the City's dedication to sustainability and social equity. While the official notification of the award is pending, University City is already listed as a grant recipient. Once finalized, the City will conduct a competitive bidding process to select contractors for the installation and maintenance of the stations, ensuring transparency, value and minority participation.

These EV charging stations will provide safe, accessible, 24/7 public charging options in City-owned parking lots and garages. Located in one of the region's cultural and economic hubs, the charging stations will not only support local businesses and tourism but also benefit underserved and disadvantaged communities by breaking down barriers to EV adoption.

Heman Park Swimming Pool

Get ready to splash into summer at our beloved Heman Park Swimming Pool. The 2025 season begins on Sat., May 24 and ends on Mon., Sept. 1.

Lap Swim Hours: Monday – Sunday and Holidays 6 a.m. to 9 a.m.

Public Swim Hours: Monday – Sunday and Holidays 12 p.m. to 8 p.m.

Purchasing a Summer Fun Pass will enable you to avoid long lines and enjoy unlimited access to the pool all season. Earlybird passes purchased Mar. 1 through May 23 also include a special invitation to the annual VIP pre-opening celebration at the pool on Fri., May 23 from 5 p.m. to 8 p.m.

Summer Fun Passes and ID cards are available at the Centennial Commons Control Desk, 7210 Olive Blvd., and are available for both residents and non-residents. Age guidelines for the pool require youth age 12 and under to be accompanied by a parent or authorized caregiver who is 18 years of age or older and who will remain with the youth the entire time they are at the pool.

General admission is limited to those age 3 and above who have a Centennial Commons membership, Summer Fun Pass, or resident/non-resident ID card, which may be purchased by residents for \$5 each and by nonresidents for \$7 each. To access the pool, both residents and nonresidents must show their ID card and pay the daily admission fee.

In addition to the general admission process, registration is also available for swim activities including swim lessons for youth and adults and a variety of Fitness Aquatic classes. Information is available at ucitymo.org/101/Heman-Park-Swimming-Pool.

The City encourages and appreciates timely payment of fees assessed for each property. Various payment options are available including:



Online Payments: Tyler Payments is a free online service that allows residents to view their solid waste account activity, make payments and receive an email to view billing statements. To sign up, go to ucitymo.org and choose the Online Bill Pay icon, which will redirect you to the Online Bill Pay (Tyler Payments) screen. Follow the steps to setup a new or existing account. If you have difficulty logging into your account or have questions about how to navigate the system, please contact the Finance Department at 314.505.8544. The system only allows for payments using a debit or credit card with a Visa or MasterCard logo.

Electronic Funds Transfer

(Bank Drafting): The Electronic Funds Transfer program for solid waste billing allows solid payments to be automatically debited from your account five business days before the due date and applied directly to your solid waste bill. To choose the Electronic Funds Transfer, please contact the Finance Department at 314.505.8544 for further assistance.

Cash, Check and Charge:

Solid waste bills can be paid by cash, check and debit or credit card. Cash must be paid in person at the Finance Department, checks can be paid either in person or regular mail and credit card payments are accepted either in person or via phone by contacting the Finance Department mainline at 314.505.8544. The City only accepts Visa and MasterCard. There is no convenience fee charge for debit or credit card payment processing.

Annual Billing for Solid Waste Services Begins March 1

March 1 is the first billing date for solid waste (refuse) services, including trash, recycling, yard waste and bulk item collection. All services are billed in advance and statements are issued by the Finance Department in six month cycles. ([See table.](#))

Solid waste fees not paid 30 days after the beginning of the service period for which the bill is issued shall be considered delinquent or past due. [See table.](#)

Senior citizens living in single or two-family houses may be eligible for a discount on solid waste services if they meet the following conditions:

- At least one resident of the property must be at least 65 years of age
- No more than two people living in the housing unit (*number of occupants listed on application will be checked against occupancy permit*)
- Resident must agree to accept a smaller trash receptacle if you have a roll-out cart (60 gallon).

UCPD Offers Free Security Assessment Services

Staying vigilant in every environment is a "best practice" for everyone. Whether you're visiting a religious institution, attending a movie or sporting event, participating in a school activity, or simply managing your property, remaining observant and prepared to respond to unexpected situations is crucial.

The University City Police Department (UCPD) offers free security assessments for residential properties, private businesses, religious institutions, and schools. Guided by Crime Prevention Through Environmental Design (CPTED) principles, these evaluations help strengthen awareness of potential soft targets.

The Importance of Mental Preparation

Increasing awareness and mental preparedness when visiting or patronizing unfamiliar buildings can significantly enhance your ability to respond effectively in unexpected situations. Mental readiness offers several benefits, including faster response times, reduced fear, confidence in decision-making, and resilience under stress.

To prepare for the "worst-case" scenario, consider the following tips:

- **Remain calm: Practice stress-management techniques**
- **Stay focused: Be an attentive observer and witness**
- **Identify potential risks: Be aware of possible threats**
- **Know your exits: Locate them as soon as you enter a building**
- **Follow the "Run, Hide, Fight" protocol: Embrace this response**



Training and Resources for Mental Preparedness

While public safety professionals routinely engage in virtual training, role-playing, and practical demonstrations, most civilians lack exposure to such crisis preparation. However, free online mental preparedness training is available from reputable organizations like the American Red Cross, the Federal Emergency Management Agency (FEMA), and the National Alliance on Mental Illness (NAMI). Additionally, law enforcement agencies, including the UCPD, often host annual Citizens' Police Academies. These programs provide participants with hands-on experience and strategic insights for handling emergencies, fostering greater community resilience.

The Role of Mental and Muscle Memory

Law enforcement officers regularly run through "what if" scenarios to build mental and muscle memory, enhancing their ability to respond swiftly and effectively. Similarly, fostering mental preparedness among community members can create a collective mindset of vigilance, contributing to a safer community.

Collaborative Efforts for Community Safety

The UCPD actively collaborates with other law enforcement agencies through mutual aid agreements, ensuring readiness to address crises on a broader scale. By promoting mental preparedness and engaging stakeholders, the UCPD aims to empower the community to take an active role in maintaining safety and security.

Fire Department Urges Caution When Digging

Spring is the perfect time of year to tackle those extensive yard projects you've been planning over the winter months. If your project involves digging large holes or working below the normal level of the yard, here are a few essential safety tips to keep in mind:

1. Contact Missouri 811 Before You Dig

Before starting any digging project, it's crucial to ensure the area is free of buried electrical gas or cable lines. To schedule a locate request, visit www.missouri-811.org or call 811 or 1.800.DIG.RITE (800.344.7483). Having all buried hazards clearly marked not only ensures you're digging in a safe, obstruction-free area, but it also helps prevent potential accidents or service interruptions.

2. Exercise Caution When Working in Trenches

Working in deep holes or trenches can be hazardous if proper precautions are not taken. Follow these guidelines for your safety:

- Never work in a hole or trench deeper than your waist without bracing the side walls. Even if the ground seems stable, it can become unstable quickly. A collapse could trap you, making escape impossible and potentially restricting your breathing.
- For projects requiring deeper trenches, consider hiring a licensed contractor with the expertise and equipment to ensure safe excavation.

3. Reach Out for Assistance

If you have questions or concerns about safety during your project, don't hesitate to contact the University City Fire Department at 314.505.8591 to ensure your project is completed safely.
